## To Taita Cricket players, supporters, and sponsors

## OPERATING RICOH SPORTS CENTRE AS A VACCINATED FACILITY UNDER THE TRAFFIC LIGHT ORANGE REGULATIONS HOW:

- 1. One entrance only to the facility the main North Entrance Door all other access doors will be locked down
- 2. Changing rooms are not going to be considered as part of "Clubrooms/Facility" so teams coming to play can enter the changing rooms go and play their game get changed and leave. Scanning codes will be put up on the exterior walls to the changing rooms. Only the main player gate and the cricket player gate will be open. The West Player gate will be locked down. The Door from the facility to the changing rooms will be locked so anyone from the changing rooms coming into the facility will need to come to the main door for verification.
- 3. Outdoor and Indoor signage will be erected stating we are a "Fully Vaccinated Facility" and directions to Reception
- 4. Barrier arms and signage indicating everyone must go to reception upon entering the building to be verified, will be placed from the Main door to Reception. Reception will be manned from 8 a.m. 8 p.m. seven days of the week.
- 5. Players only access to the balcony from the front of the facility, a sign and rope will prevent non players from accessing the balcony from the ground
- 6. when there is a function the balcony will be ropped off into two parts, players to the left of the main door and spectators to the right
- 7. The Bar will be open as normal, but no one can come in after 8 p.m. unless a member in the bar comes and opens the door and then that person will be verified at the bar.
- 8. It is essential that we verify every person coming into the facility and one of the team would permanently be seated at the Reception Desk our tablets will have the vaccine verifying app downloaded for instant confirmation when vac pass is scanned
- 9. Reception manned currently
  - a. 8 a.m. 8 p.m. Monday Wednesday Thurs Friday (no change)
  - b. 8 a.m. 4.00 p.m. Tuesdays (will now be extended to 8 p.m.)
  - c. 8 a.m. 4.00 p.m. Saturday and Sunday (will now be extended to 8 p.m.)
- 10. All staff, onsite contractors and tenants will be required to be vaccinated.
- 11. Functions: the function organiser will be required to check and make a declaration that all participants are vaccinated. FPS staff will liaise with groups as required and arrange

- group entry to the facility if that is the best option. Full or spot checks of vaccine passes will be undertaken.
- 12. Cafe, Bar, walk ins: all people entering the facility will be required to report to reception to show their vaccine pass.
- 13. Sports/clubs/member organisations: all people entering the facility (excluding the changing rooms) will be required to report to reception to show proof of vaccination; where re-entry through a period/day occurs, we will look to implement a system to enable those that have already had their vaccine pass checked to re-enter more quickly (eg with a stamp as a possible example).
- 14. Outdoor sport itself is not impacted by the decision to make the facility a vaccination only facility.
- 15. FPS will need our support and we will work closely with the clubs and make changes on an ongoing basis as we work through how the facility will operate under the traffic light system. We are all aware that this will be subject to change as further information, experience and rule changes are issued by the government. Following Sports NZ guidelines that are to be released hopefully today on how sports will operate under the traffic light system we will then work to you to integrate any changes that need to be made.
